Sarah,

As we discussed, the following is the tentative settlement agreement to have a global settlement of all issues. The terms are:

Payment of 4 million dollars to Ms. Hambley.

Ms. Hambley resigns from her position but will remain in office until 12/15/23 at the latest. Marcia Mansaray will resign from her position and her final day will be 1/31/23. She will be placed on paid administrative leave two days after the signing of the agreement. She will also receive one year severance with benefits or until such time as she has obtained employment at 75% of what she earned at Ottawa county.

All parties, including Ms. Mansaray, well execute a full and final release of all claims, known and unknown, and will dismiss all pending litigation. The county will not appeal the court of appeals decision in Hambley v Ottawa county.

The county will continue its liability coverage for Ms. Hambley and Ms. Mansaray for any acts they committed while in their official capacity.
